Paymaster - Reports were submitted to the BOD via email. Jaglinski made a motion to accept,

Hintz seconded. The motion carried unanimously. Janssen said that the 990 is almost complete and that when we receive it, we should review page 7 for accuracy. He also indicated that we would update and sign the Conflict of

Interest forms at the next meeting.

Committee Reports:

Meets: The March 17th meet at the Oconomowoc Area Historical Society is all set

including clinics and layout tours. The April 17th meet will be held at the Four Points Sheraton and will include the annual business meeting and results of the

election. At this time, we do not have clinics or layout tours in place.

Contests: We have a Youth category for contests which is available at all WISE meets. So,

if we have 2 or more entries in the category, we will have a contest. Jaglinski stated that he will publicize the contest and the Youth Group through the

Trainfest mailing lists.

Owl Car: The February issue should be out by the 5th in the mail, up on web and

distributed by the same date. The March issue will be mailed to all members of record with the ballot. Deadline for articles is 2/25/19. April will be back to digital/print. Deadline is 3/27/19. The May issue will run a little later due to the

meet being on 4/28. Deadline is May 6 (after DuPage). Still debating on the

summer issue.

Youth Grp: The Wilson Park Model RR Club has donated items to the Youth Group. South

Side Trains has offered to be a depository for anyone who would like to donate items to that group. In addition to South Side Trains, the three other shops have

agreed to carry brochures about the WISE Youth Group.

Video: Burnell Breaker reported that 4 DVDs were signed out at the last meet by two

individuals.

Membership: 175 on roster --- Associate Members 51, Family Member 6, Regular Member 79,

Rail Pass 7, Sustaining Member 2 (1 club, 1 manufacturer), Student 1, Life

Member 24, Life Family 5. The majority of membership lives in Milwaukee & Waukesha counties. In addition, we have 61 on our non-member list. Youth – 6, Members from other divisions – 10, Guests – 45. Mike Slater will provide a breakdown by county for the next meeting.

Bus Trips: So far twenty-one2119) have signed up for the Mad City Show. After the show

the group will tour Roy Grant's Omaha and Western RR. After the bus trip to Du Page, the group will tour Wayne Pelke's Denver Junction Western Pacific RR.

Website: Changes are in the works and older Owl Car issues will be available soon.

Trainfest: Ken announced that we currently have 29 exhibitors signed up for Trainfest

2019. They consist of Displays – 1, Historical Selling – 2, Layouts – 17,

Manufacturers -5, and Vendors -4.

In addition, we have received a \$5000.00 Grant from the BNSF Foundation. We will be giving them credit as the show sponsor, on the Historical Display and in

our promotional material.

WISE Ops: Andy Greco reported that he has contacted all the layouts that have previously

participated and has 9 committed with about 70 operating slots for the Spring WISE Ops. Emails have been sent to all the layouts and historical societies that participate in Trainfest, to our membership, to our non-members, and to those on

the Visual Response list reminding them to save the date and respond to nmrawiseop@gmail.com if interested. Fliers have also been distributed to the

local hobby shops.

We will be planning a fall WISE Ops event if the spring one goes well. It will not

be the same weekend as Optoberfest.

BOD Dinner: No report

Locations: It was suggested that we could use the West Allis Library and the Lionel Railroad

Club of Milwaukee club house as possible BOD meeting sites.

Elections: We currently have the following slate of candidates. Mike Slater –

and several publications like Scale Rails and Kalmbach Magazines. He will be

assisted by Andy Breaker.

Andriesen or the Milwaukee Traction awards that have been given out at regional conventions. Steve Miazga is to investigate if we purchased them from Ralley

Co.

A motion was made by Slater to formally accept the resignation of Joe Russ as Superintendent. It was seconded by Miazga and the motion carried unanimously.
