- RPM Meet Sept 2020 Admission fee for non NMRA members was set at \$2. Now we can get info ready to advertise this event.

New Business:

- Motion to pay the church the same amount we pay for the Hotel (\$500). Motion made by Janssen, 2nd by Zieger, B. Breaker abstained as he is a member of the church. Motion passed.

- Janssen stated the 990-tax return has been completed and was given to Sherman to review, then to the rest of the BOD for final review.
