#### Trainfest:

# (Slater/Janssen) –

- Janssen emailed letters to all attendees on record indicating that they could request a refund or apply their deposit to the 2021 show.
- Slater explained that a meeting with John Tews was requested. He indicated
  that he (Tews) would be willing to take over the Trainfest Chair but wanted full
  control of not only the direction of the show but the financial aspect also. In
  addition, he would restore our bond with Mercury in marketing the show.
  Slater had requested to have a proposal submitted. This did not happen and
  the suggestion by Tews was dismissed.
- It is believed that Ken Jaglinski did not understand our change in how volunteer hours would be used which then turned into a great deal of confusion. This was particularly enhanced by many attendees communicating with Jaglinski, believing him to continue to be the primary contact for Trainfest.

### **New Business:**

- Slater stated via an email from Hintz that WCGD (Waukesha County Gandy Dancers) will accept the WISE Div. Youth layout. Miazga motioned and 2<sup>nd</sup> by Grieshaber. This will also include the WISE Guys & Gals layout, the N scale layout, the DIgiTrax DCC, supplies and excess track in storage. Motion approved.
- The switching layout that Jaglinski, Grieshaber, and Hintz built has been
  offered to Betty Brin and WCGD with no takers, Tri-County has no room,
  Metro Club in Port Washington has no time, and they have not opened up yet.
  It is 22 x 18 plus corners. Was suggested to take pictures, and put on eBay or

- Facebook Market Place. Has 9 sections 48" x 30". Miazga suggested to offer it to division members, then MWR (Mid West Region), then to the public.
- Created a date to clean out storage unit, which will be July 18 Saturday. Need to remove "Make-it Take-it", Junior Engineer. The Celebrate a Railroad panels are at Discovery World.
- Trainfest Builders layout has corners.
- Slater to contact SCWD (South Central WIs Division) in Madison on how to handle the youth layout.
- Greco asked if a group of WISE Div. members can organize the junior engineer program? Yes, provided it is not connected with the Division.
- Discussed that Dave Poquette is interested in doing the AP (Achievement Director) position. Need to discuss this with Children. The topic was tabled.
- WCGD has no youth coming into the facility yet, So Hintz is no longer responsible for the Youth Program.
- Slater asked Hintz if he was interested in doing the membership duties. He
  declined due to his work schedule. Grieshaber said he would be interested in
  this. There is a form letter to send to past due members.

The meeting adjourned about 8:27 PM. Motioned by Zeiger, seconded by Greco, all were in favor.
