Paymaster - Reports were submitted by Janssen to the BOD via email. Janssen stated we

need to do a fundraising campaign. Or find a way to cut expenses. Mercury had done some fundraising. Jeff Marker was going to do a fundraising (grant request) but has resigned. We did get a \$1300 insurance refund, due to Covid, but had a

\$2500 bill. Normal expenses per year are \$12k.

month, or \$150 for 12 months (you get 2 months free, or save \$30)

- Slater and crew sorted items at the storage locker July 18, removing Junior Engineer items and participant records (Items removed and records were burned)
- Fall Harvest Days in Union Grove has been canceled.
- Hotel charge is \$500 for April and September.

New Business:

- A show of hands on holding the RPM Meet, no = 5, yes = 2, out of 9 present.
- Miazga motioned to not do the in-person events thru the end of 2020. 2nd by Grieshaber, motion approved with one opposed. It was suggested to do a virtual event, if possible.
- Discussed how to cut down on storage expense, by moving items to the Sturtevant Museum. Would need to build a wood partition with a separate door, in the box car. The LRRC has a trailer we could do move with. The Make-it-take it stuff can be donated or sold at swaps or eBay. The Division has a PayPal account, and can create an eBay account. We could also list

old Trainfest merchandise. Was suggested to move to a smaller storage unit in New Berlin, which is more convenient to State Fair location.

- Owl Car WISE Div. Events schedule has been reduced to near zero.
- Hebner was instructed to change the RPM meet In-Person is canceled, virtual event pending. And the October Meet to change to virtual. Stay tuned for in-person events.
- Slater will talk with other division superintendents for other ideas on virtual events or issues.
